FOR LIBRARY PATRONS OF ALL AGES, ACCESS TO TECHNOLOGY IS CRITICAL. MANY PATRONS DEPEND ON THE LIBRARY'S COMPUTERS AND WI-FI TO COMPLETE HOMEWORK, APPLY FOR JOBS AND ACCESS CRITICAL SERVICES. THE LIBRARY FOUNDATION HELPS THE LIBRARY SYSTEM PURCHASE AND MAINTAIN INNOVATIVE TECHNOLOGY EQUIPMENT AND OFFER DIGITAL ACCESSIBILITY TRAINING TO PATRONS.
